

KNOWN ALL MEN BY THESE PRESENTS:

THIS CONTRACT, made the DEC 13 2021 day of _____ 2021 between the PHILIPPINE PUBLIC SAFETY COLLEGE (PPSC) Lot 2 MWSS Compound Katipunan Avenue corner Ayala Heights, Old Balara Quezon City (*hereinafter called "the Entity"*) of the one part and MARCELINO P. SIRINGAN REF & AIRCON REPAIR SERVICES, with office address at Phase 1 Diversion Rd. Pallua Sur Tuguegarao City, Cagayan hereinafter called "*the Contractor*" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **PROCUREMENT OF SERVICES FOR THE PREVENTIVE MAINTENANCE OF FIFTY-TWO (52) UNITS AIRCON FOR THREE (3) MONTHS AT THE PPSC HEAD OFFICE - RFQ BAC NO.2021-030** and has accepted a Bid by the Contractor for the supply of those services in the sum of **ONE HUNDRED TWENTY-FOUR THOUSAND EIGHT HUNDRED PESOS ONLY (Php124,800.00)** hereinafter called "*the Contract Price*".

NOW, THIS CONTRACT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No.9184 shall be deemed to form, and be read and construed as part of this Agreement, *viz.*
 - i. Philippine Bidding Documents (PBDs);
 - I. Request for Quotation (RFQ)
 - II. Terms of Reference
 - III. Schedule of Requirements;
 - IV. Technical Specifications;
 - V. General and Special Conditions of the Contract; and
 - VI. Supplemental or Bid Bulletin, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring entity's bid evaluation;
 - iii. Notice of Award of contract; and the Bidder's conforme thereto; and
 - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD's. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **ONE HUNDRED TWENTY-FOUR THOUSAND EIGHT HUNDRED PESOS ONLY (Php124,800.00)** or such other sums as may be ascertained. MARCELINO P. SIRINGAN REF & AIRCON REPAIR SERVICES agrees to **PROCUREMENT OF SERVICES FOR THE PREVENTIVE MAINTENANCE OF FIFTY-TWO (52) UNITS AIRCON FOR THREE (3) MONTHS AT THE PPSC HEAD OFFICE - RFQ BAC NO.2021-030** in accordance with his/her/its Bid.
4. The PHILIPPINE PUBLIC SAFETY COLLEGE (PPSC) agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
