INVITATION TO RE-BID

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PPSC now invites bids for *the procurement of the above-captioned package*. Delivery and installation of the goods is required for sixty (60) calendar days upon final approval of the Notice to Proceed (NTP).
3. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. *Instructions to Bidders*.
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

5. Interested bidders may obtain further information from the BAC Secretariat Office, 2F Lot 2 MWSS Compound Katipunan Road corner Ayala Heights, Brgy. Old Balara Quezon City and inspect the Bidding Documents at the address given above from *8:00 a.m. – 4:00 p.m., Monday – Friday*.
6. A complete set of Bidding Documents may be purchased by interested Bidders on ***July 28, 2020 – August 17, 2020*** from the address above and upon payment of nonrefundable fees for the Bidding documents in the amount of **Five Thousand Pesos (Php5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders who are interested to participate shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

7. The PPSC will hold a Pre-Bid Conference on ***August 05, 2020 1PM*** at the *PPSC Conference Room 3F Lot 2 MWSS Compound Katipunan Road corner Ayala Heights, Brgy. Old Balara Quezon City* which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat at the address below on or before ***9:00 AM, August 17, 2020 PPSC Conference Room 3F Lot 2 MWSS Compound Katipunan Road corner Ayala Heights, Brgy. Old Balara Quezon City***. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on ***August 17, 2020 10:00 AM, PPSC Conference Room 3F Lot 2 MWSS Compound Katipunan Road corner Ayala Heights, Brgy. Old Balara Quezon City***. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

9. **The PPSC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.**
