1. The *Philippine Public Safety College* through the *National Expenditure Program (NEP) FY2020* intends to conduct **Early Procurement (short of award)** and apply the sum indicated below being the Approved Budget for the Contract (ABC), to payments under the contract for *the PROCUREMENT OF QUARTERMASTER SUPPLIES 1st Semester FY2020;*

Bids received in excess of the ABC shall be automatically rejected at bid opening.

The PPSC now invites bids for the procurement of the above-captioned package. Delivery of the goods is required within **forty-five (45) calendar days after issuance of Notice to Proceed (NTP)**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. *Instructions to Bidders*.

2. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

3. Interested bidders may obtain further information from the BAC Secretariat, 2F PPSC Lot 2 MWSS Compound Katipunan Avenue corner Ayala Heights Old Balara, Quezon City and inspect the Bidding Documents at the address given above from *8:00 a.m. – 4:00 p.m., Monday – Friday*.
4. A complete set of Bidding Documents may be purchased by interested Bidders on ***November 20, 2019 – December 10, 2019*** from the address above and upon payment of nonrefundable fees for the Bidding documents in the amount of **Ten Thousand Pesos (PhP10,000.00) for LOTS 2, 3 & 4, Five Thousand Pesos (PhP5,000.00) for LOTS 1, 5 & 6 and Five Hundred Pesos (PhP500.00) for Lot 6**.
5. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders who are interested to participate shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
6. The PPSC will hold a Pre-Bid Conference on ***November 28, 2019 10AM*** at the *Quezon City Sports Club (QCSC) E. Rodriguez Sr. Blvd. Quezon City* which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before ***9:00 AM, December 10, 2019*** PPSC Conference Room 3rd Floor PPSC Lot 2 MWSS Compound Katipunan Avenue corner Ayala Heights Old Balara, Quezon City. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
8. Bid opening shall be on ***December 10, 2019 10:00 AM***, PPSC Conference Room, 3F PPSC Lot 2 MWSS Compound Katipunan Avenue corner Ayala Heights Old Balara, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
9. **The PPSC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.**
