INVITATION TO BID

PROCUREMENT OF PPSC SUPPLIES (AMMUNITION FOR THE 4TH QUARTER)

1. The *Philippine Public Safety College* through the *General Appropriations Act of 2018*, intends to apply the sum indicated below being the Approved Budget for the Contract (ABC), to payments under the contract for *the PROCUREMENT OF PPSC SUPPLIES (AMMUNITION FOR THE 4TH QUARTER)*;

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The PPSC now invites bids for *the procurement of the above-captioned package*. Delivery of the goods is required for thirty (30) days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. *Instructions to Bidders*.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary *“pass/fail”* criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the BAC Secretariat, 4F Al-fer Building, 505 EDSA corner Col. Bonny Serrano Avenue, Quezon City and inspect the Bidding Documents at the address given above from *8:00 a.m. – 4:00 p.m., Monday – Friday.*
5. A complete set of Bidding Documents may be purchased by interested Bidders on ***October 16, 2018 – November 05, 2018*** from the address above and upon payment of nonrefundable fees for the Bidding documents in the amount of **Ten Thousand Pesos (PhP10,000.00) for LOT 1, Ten Thousand Pesos (PhP10,000.00) for LOT 2 & Five Hundred Pesos (PhP500.00) for LOT 3.**
6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPs) and the website of the Procuring Entity, provided that Bidders who are interested to participate shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.
7. The PPSC will hold a Pre-Bid Conference on ***October 24, 2018 10:00AM*** at the *PPSC Conference Room 3F ALFER Building 505 EDSA, Quezon City* which shall be open to prospective bidders.
8. Bids must be duly received by the BAC Secretariat at the address below on or before ***9:00 AM, November 05, 2018*** *PPSC Conference Room 3F ALFER Building 505 EDSA, Quezon City.* All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on ***November 05, 2018 10:00 AM, PPSC Conference Room, 3F ALFER Building 505 EDSA corner Col. Bonny Serrano Avenue, Quezon City.*** Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

9. **The PPSC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.**
