**CONSTRUCTION OF TWO (2) STOREY TWO HUNDRED (200) CAPACITY DORMITORY

1. The *Philippine Public Safety College (PPSC)* through the *National Expenditure Program (NEP) FY2019* intends the conduct of Early Procurement (*short of award*) as per DBM Circular Letter No.2018-8 and apply the sum indicated below being the Approved Budget for the Contract (ABC), to payments under the contract for the **CONSTRUCTION OF TWO (2) STOREY TWO HUNDRED (200) CAPACITY DORMITORY WITH ROOF DECK AT THE REGIONAL TRAINING CENTER 3 (RTC 3)**;

Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The *PPSC* invites bids for *the procurement of the above-mentioned project*. Completion of works shall be within *Two Hundred Forty (240) Calendar Days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II of the Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Revised Implementing Rules and Regulations (RIRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy-five (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the PPSC SBAC Secretariat Office 4F ALFER Building 505 EDSA corner Col. Bonny Serrano Avenue, Quezon City and inspect the Bidding Documents at the address given below from *8:00 a.m. – 4:00 p.m., Monday – Friday*.
5. A complete set of Bidding Documents may be purchased by interested Bidders on ***December 31, 2018 – January 21, 2019*** from the address below and upon payment of a **non-refundable fee** for the Bidding Documents in the amount of **Twenty-Five Thousand Pesos (PhP25,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the nonrefundable fee for the Bidding Documents not later than the submission of their bids.

6. The PPSC SBAC2 will hold a Pre-Bid Conference on ***January 08, 2019 @ 2PM*** at the *PPSC Conference Room 3F Af-Fer Building 505 EDSA, Quezon City* which shall be open to prospective bidders.
7. Bids must be duly received by the SBAC Secretariat at the *PPSC Conference Room 3F Af-Fer Building 505 EDSA, Quezon City* on or before ***January 21, 2019 @ 9AM***. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Bid opening shall be on ***January 21, 2019 @ 10AM, 3F Al-Fer Building 505 EDSA corner Bonny Serrano Avenue, Quezon City***. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. **The *PPSC SBAC 2* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.**
