PROCUREMENT OF JANITORIAL SERVICES & SUPPLIES FOR THE PPSC HEAD OFFICE FY2022 - PPSC BAC IB NO.010 (S) 2021

KNOWN ALL MEN BY THESE PRESENTS:

THIS CONTRACT, made the ___ day of JAN 21 2022 2022 by between the PHILIPPINE PUBLIC SAFETY COLLEGE (PPSC), Government Agency of the Philippines, represented herein by PLTGEN RICARDO F DE LEON, (Ret.), Ph.D., *President* with office address at Lot 2 MWSS Compound Katipunan Avenue corner Ayala Heights, Old Balara Quezon City (*hereinafter called "the Entity"*) of the one part and D' TRIUMPH CLEANERS AND ALLIED SERVICES, INC. represented herein by MARION M. MAALA, *Authorized Representative* with office address at 394 Molino Road, San Nicolas III Bacoor City, Cavite 4102 hereinafter called "*the Supplier/Contractor*" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the PROCUREMENT OF JANITORIAL SERVICES & SUPPLIES FOR THE PPSC HEAD OFFICE FY2022 - PPSC BAC IB NO.010 (S) 2021 and has accepted a Bid by the Supplier/Contractor for the supply of those goods and services in the sum of THREE MILLION EIGHT HUNDRED NINETY-EIGHT THOUSAND PESOS AND SIXTY-FOUR CENTAVOS (Php3,898,000.64) hereinafter called "*the Contract Price*".

NOW, THIS CONTRACT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No.9184 shall be deemed to form, and be read and construed as part of this Agreement, viz:
 - i. Philippine Bidding Documents (PBDs);
 - I. Schedule of Requirements (13 Janitorial Personnel for 12months/1yr. including materials to be provided on a monthly basis and on quarterly basis;
 - II. Technical Specifications/Terms of Reference;
 - III. General and Special Conditions of the Contract; and
 - IV. Supplemental or Bid Bulletin, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD's. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of THREE MILLION EIGHT HUNDRED NINETY-EIGHT THOUSAND PESOS AND SIXTY-FOUR CENTAVOS (Php3,898,000.64) or such


