CONTRACT OF SERVICES

DISINFECTION TREATMENT SERVICES FOR THE PPSC HEAD OFFICE FY2022
(January to December 2022)

KNOWN ALL MEN BY THESE PRESENTS:

THIS AGREEMENT, made the ____ day of 21 JAN 2022 20____ by between PHILIPPINE PUBLIC SAFETY COLLEGE (PPSC) Government Agency of the Philippines, represented herein by PLTGEN RICARDO F DE LEON (Ret.), Ph.D., President with office address at Lot 2 MWSS Compound Katipunan Avenue corner Ayala Heights, Brgy. Old Balara Quezon City (herein called the "ENTITY") of the one part and **POWER HOUSE PEST CONTROL SERVICES** represented herein by ANNA MARIE M. ESCOBER, Sole Proprietor Filipino with principal business address at 2422 R. Fernandez St. Gagalangin Tondo 1013 Manila (herein called the "SUPPLIER/SERVICE PROVIDER") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the **DISINFECTION TREATMENT SERVICES FOR THE PPSC HEAD OFFICE FY2022 (January to December 2022 - two times/month) - PPSC BAC IB NO.012 (S) 2021 ("the Services")** and has accepted the Bid for the supply of those goods and services in the sum of ONE HUNDRED SIXTY-FIVE THOUSAND SEVEN HUNDRED SEVENTY-SEVEN PESOS (Php165,777.00) hereinafter called "the Contract Price").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No.9184 shall be deemed to form and be read and construed as integral part of this Agreement, to *viz*:
 - i. Philippine Bidding Documents (PBD's):
 - A. Terms and Conditions of the RFQ
 - B. Technical Specifications
 - C. Terms of Reference
 - D. Priced Bill of Quantities, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes
 - E. Performance Security
 - F. Notice of Award of Contract and the Bidder's conforme thereto;
 - ii. Winning bidder's bid, including the Eligibility Documents, Technical and Financial Proposals, and all other documents or statements submitted:
 - iii. Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidders response to request for clarifications on the bid) including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iv. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD's. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders shall likewise form part of the Contract.
 - v. In consideration for the sum of ONE HUNDRED SIXTY-FIVE THOUSAND SEVEN HUNDRED SEVENTY-SEVEN PESOS (Php165,777.00) or such other sums as may be ascertained. **POWER HOUSE PEST CONTROL SERVICES** agrees to the DISINFECTION TREATMENT SERVICES FOR THE PPSC HEAD OFFICE FY2022 (January to December 2022) in accordance with his/her/its Bid

vi. The PPSC agrees to pay the abovementioned sum in accordance with the terms of the Bidding.




