PROCUREMENT OF FIVE (5) UNITS AIRCON WITH INSTALLATION FOR THE MATATAG HALL - PPSC BAC IB NO.021(G) 2021

KNOWN ALL MEN BY THESE PRESENTS:

THIS CONTRACT, made the JAN 21 2022 day of 2022 by between the PHILIPPINE PUBLIC SAFETY COLLEGE (PPSC), Government Agency of the Philippines, represented herein by PLTGEN RICARDO F DE LEON, (Ret.), Ph.D., *President* with office address at Lot 2 MWSS Compound Katipunan Avenue corner Ayala Heights, Old Balara Quezon City (*hereinafter called "the Entity"*) of the one part and AEQUUS ENTERPRISE represented herein by CHRISTY ANN BARE, *Authorized Representative* with office address at 20B Commonwealth Village I Commonwealth Avenue Old Balara, Quezon City hereinafter called "*the Supplier*" of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the PROCUREMENT OF FIVE (5) UNITS AIRCON WITH INSTALLATION FOR THE MATATAG HALL (2 Units 2HP Inverter Type, 3 Units 5Tonner Type with Installation)- PPSC BAC IB NO.021 (G) 2021 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of SIX HUNDRED EIGHTY-FOUR THOUSAND THREE HUNDRED SIX PESOS (Php684,306.00), hereinafter called "*the Contract Price*".

NOW, THIS CONTRACT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No.9184 shall be deemed to form, and be read and construed as part of this Agreement, viz.
 - i. Philippine Bidding Documents (PBDs);
 - I. Schedule of Requirements 2 Units 2HP Inverter Type, 3 Units 5Tonner Type with Installation (Delivery and installation required within fifteen (15) calendar days)
 - II. Technical Specifications KOPPEL Super Inverter III (KV18WM-ARF21C2 / AUX Air Conditioner (Floor Mounted);
 - III. General and Special Conditions of the Contract; and
 - IV. Supplemental or Bid Bulletin, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g. Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD's. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.



AEQUUS ENTERPRISE agrees to PROCUREMENT OF FIVE (5) UNITS AIRCON WITH INSTALLATION FOR THE MATATAG HALL - PPSC BAC IB NO.021 (G) 2021 in accordance with his/her/its Bid.

4. The PHILIPPINE PUBLIC SAFETY COLLEGE (PPSC) agrees to pay the abovementioned sum in accordance with the terms of the Bidding.

IN WITNESS, whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




